

## August 2008 Telluride/MountainVillage Meeting Summary

Chad Root (Mountain Village) and Sam Samuelson (Telluride) hosted the two day Chapter Meeting on July 31 and August 1, 2008. A very big thank you goes out to Jackie Williams (Mountain Village) and Helen Schumack (Telluride) for making all of the arrangements for the meeting rooms, the food for the meetings, reserving the Telluride Town Park tent, and the food and drink for the Thursday night picnic.

We had approximately 40 people attend the two day meetings. The meetings were held in a room at the top of the “hill” between Mountain Village and Telluride. The only way to get there was by taking the free tram which runs between the two towns. The view was fantastic and the meeting presenters were very good.

The following is a short summary of the various presenters:

Steve Barnes with Pentair Water and Spa (Worlds largest manufacturer of pool equipment) explained the issues of pool entrapment and how the Building Codes and federal legislation have been dealing with this serious problem.

He explained the 5 types of entrapment and also explained the various levels of protection that deal with the entrapment problem.

Steve also spent time explaining the recently passed federal legislation “Virginia Graeme Baker Pool and Spa Safety Act” which is effective on December 19, 2008.

Scott Bridger (owner of Bridger Construction Services) was the next presenter. Scott is a custom home builder working in the Telluride and Mountain Village area. He spent an hour talking about how he is transitioning to more energy efficient and sustainable building methods. This actually turned into an open discussion among the many code officials in attendance about the general concept of “green building codes and programs” and how they are being instituted in various areas of Colorado. The discussion also centered on what green building codes and programs should be in order to be effective. This was lively and very informative discussion.

Joani Matranga with the Governors Energy Office (GEO) was the next presenter. She is the representative for the Western Slope and went over the long list of the various programs that are available to local jurisdictions and homeowners. The next presentation was done by the folks from The New Community Coalition. Kris Holstrum, Executive Director, gave us a general overview of the group. The TNCC is a non-profit organization for San Miguel County which includes Telluride and Mountain Village. This group has been working on the development of a comprehensive regional green building code. Kim Wheels then spent time on explaining the specific details of how the group worked with the public, builders, and building departments to get the first drafts finished. Sam Samuelson (CBO for Telluride) and Chad Root (CBO for Mountain Village) explained how their jurisdictions green building codes would relate to the regional green building code.

The New Community Coalition was formed in 2007 to implement sustainability efforts in San Miguel county. The organization is funded by the Town of Telluride, Town of Mountain Village, San Miguel County, the Telluride Foundation, and San Miguel Power Association.

TNCC coordinates and manages efforts that contribute to balanced regional sustainability. These efforts encompass the three tenants of sustainability: Natural Resources and Ecology, Society and Culture, and Local Economy. In addition to the role of coordinating entity, the annual work plan will emphasize energy conservation (including enhanced green building standards), renewable energy, food security, waste reduction, environmentally responsible waste disposal and recycling programs, and relocalization efforts. Five working groups have been developed to address these issues, and are comprised of TNCC staff and community members.

The next presentation was by Steve Dunn with SWEEP (Southwest Energy Efficiency Project). He spent some time explaining what SWEEP does and how they are concentrating on above code initiatives (the 30% solution). He talked about how energy efficiency is cost effective in terms of Return on Investment. He explained how money is available from various sources including the State of Colorado.

The final presentation was done by Robby Schwartz with Energy Logic. He explained the simulated performance path for code compliance. The simulated performance path takes advantage of sound integrated systems thinking, applied building science, and performance analysis and testing in order to meet the intent of the code.

He spent the time explaining the concepts behind the performance path as compared to the prescriptive requirements as outlined in the body of the Codes. He also spent time reviewing the specific areas to be looked at both at the plan review stage and the inspection stage.
